Rules for the 2012 USSSA Southwest Illinois Baseball league will be in accordance with the Official Handbook of the United States Sports Specialty Association (USSSA) unless otherwise specified below.

1. Teams will bat their entire roster during SOUTHWEST ILLINOIS BASEBALL league, and end-of-year tournament play. The roster constitutes those players who are present and in uniform at the time of play.
2. Teams will be allowed unlimited substitutions, excluding pitchers, during SOUTHWEST ILLINOIS BASEBALL league, and end-of-year tournament play.
 - After a pitcher is removed from the game he will not be allowed to re-enter the same game as a pitcher.
3. All league games will be 6 innings in length. The “mercy rule” come into play when a team has a 15 run lead or more and 3 innings (2 ½ if the home team is winning) have been completed, 12 runs after 4 innings or 10 runs after 5 innings.
4. Once the run differential has been reached, and the game declared as being over, it is permissible for teams to keep on playing to get extra game experience. Both teams must agree to do this.
5. A game will be considered “complete” after 4 innings or 3 ½ innings if the home team is winning.. Any game that ends prior to the completion of 4 innings will be resumed from where the inning was halted.
6. **Game time limit is 1 hour and 50 minutes (1:50). This means that no new inning shall start after 1:50 has passed.**
 - a. **The clock does not start until after the first pitch of the game has been thrown.**
 - b. **If at the end of a regulation game the score is tied, and there is time still left on the clock, then extra innings may follow. If at the end of a regulation game the score is tied and there is no time left on the time limit then said game will result in a tie.**
7. **Each team is allowed to score a maximum of 5 runs per inning, with the exception of the last inning then teams will be allowed an unlimited number of runs.**
 - a. **The last inning will either be the 6th inning or when the umpire declares that due to time, the last inning is being played**
 - b. **Both teams must have an equal opportunity to score unlimited runs in the last inning.**
8. Pitching limit is set to where no pitcher shall throw more than **three** innings in any single day. It is the responsibility of the coaches and parents to monitor the number of pitches and innings a pitcher throws in any single day. All coaches and parents are required to error on the side of caution when determining whether or not any pitcher should throw another pitch or inning.

9. **Runners are allowed to lead off and steal. A runner on third base can only advance to home on a batted ball, forced walk, or an over throw by another fielder other than the catcher.**
10. **The dropped third strike rule is NOT in play. Regardless, runners on first and second are allowed to advance at their own risk. If there is a runner on third, he cannot advance on a dropped third strike or a passed ball and must be either hit in or forced in via a walk. If the catcher or pitcher attempts to pick a runner off third base, and the ball gets by the third baseman, that runner may NOT advance home.**
11. **Runners can advance from third on an overthrow in the same play sequence. For example, if a kid hits a ball and coming into third base the ball gets past the third baseman then that runner may advance home.**
12. The umpire behind the plate must be patched by a sanctioning body (IHSA, MHSA, USSSA, etc.). The base umpire is not required to be patched by a sanctioning body.
13. It is the responsibility of the head coach (or acting head coach) to ensure that players and fans exhibit proper sportsmanship at all times. Ejected players, fans and coaches will be required to depart the field of play immediately. Failure to oblige will result in forfeiture of the game.
14. Consumption of alcohol by any member of the coaching staff, or support personnel such as the score keeper, trainer, etc., prior to and/or during the game is strictly prohibited. If a member of the coaching staff or support personnel is observed consuming alcohol prior to and/or during the game, it will result in an immediate forfeit. Multiple offenses by the same team could result in eviction from the league.
15. League play can begin on April 1, 2012.
16. It is the responsibility of each team to complete their schedule, including rainouts, prior to the league tournament. Any dispute regarding scheduling conflicts, games played or anything else not covered in these rules must be presented to the league commissioners by July 5, 2012 for resolution.
17. All head-to head league games must be completed by July 5, 2012. The league tournament is scheduled for July 8 – July 15
18. The format of the league tournament will be determined at a later date and is dependent upon the total number of teams in the league. It is our goal to have tournament format that is a bracket style format. Teams will be seeded based off the total number of points accumulated during league play.
19. Rosters
 - a. A player shall be permitted to participate on no more than two teams but only one team per age division. For the league tournament, any player who is on 2 teams will only be allowed to pitch for one team and that must be declared to the league commissioner before the start of the tournament
 - b. **Initial rosters will need to be turned in no later than April 1, 2012.** Changes to your roster must be turned in to the league commissioner and accepted by the league board before the player is allowed to play in any league game

- c. **Roster changes will be allowed until June 1, 2012 at which time the roster becomes frozen.**
 - d. If a roster change is needed after the June 1, 2012 deadline then that request must be submitted in writing to the league commissioners and the request will be reviewed by the league board for approval
 - e. If a team uses a player in any game who is not on the approved roster then that game will result in a 1-0 forfeit and the manager will be suspended for two games
 - f. Rosters will be posted on the league website and made accessible only to the team representative who has access to the site (this would be the person who posts scores for your team)
 - g. When submitting a lineup card to the opposing team, coaches must use the players last name and number
 - h. **At the home plate meeting prior to the start of the game, both coaches must present their scorebooks with the lineups written in for verification and approval. Once the coach indicates his lineup as presented is correct, then the home plate umpire will initial the scorebook indicating such.**
 - i. Roster challenges will require a \$50 fee paid to the league before the challenge will be heard
20. It is the responsibility of the home team to ensure that all applicable rules affiliated with their “home field” of play get reviewed with the visiting coach and umpires prior to the start of the game. Upon completion of the “home field” rules review it is the responsibility of both teams to ensure that no violations occur. Violations may result in the forfeiture of the game.
21. Disputes or disagreements must be brought forth to the league commissioners for resolution. NOTE: There will be a protest fee of \$75 for any game that is going to be played under protest. If a team wishes to protest a game, they must declare such at the time of infraction. If a team does not declare they are going to protest at the time of infraction, then the protest will not be allowed..
22. Players that depart the game for any other reason besides injury will have their spot in the lineup considered as an out each time that the missing players spot in the batting order comes up.
- i. A player leaving any game due to injury may not return to play in the same game. When his spot in the batting lineup comes up he will be skipped over.
23. It is not imperative that baseball coaches wear team baseball cap or be dressed in team attire during the game.
24. A courtesy runner for the pitcher and catcher is allowed at any time. The player which recorded the last batted out must be used first and can only be used one time per inning. In the event that the player which recorded the last batted out has already been used the previous batter that recorded a batted out is to be used next.
- 25. All balks will be considered warnings and the ball considered dead at the time the balk is called.**
26. The hosting team will be required to supply 2 new league baseballs for each game. No rubber coated, plastic, or obviously defective baseballs are allowed.
- 27. It is the responsibility of the winning team to post game scores on the league website no later than 24 hours after the conclusion of the game.**

28. If a game gets cancelled for any reason other than weather or a school-related event, then that game will result in a 1-0 forfeit.
- 29. The new USSSA bat rules will be followed.**
- a. Big Barrel bats (2 5/8" or 2 3/4") must have the new USSSA mark on its taper OR be a qualified BBCOR bat OR be a wood bat**
 - b. Small Barrel bats (2 1/4" or less) must have the new USSSA mark on its taper OR have the old USSSA mark OR be a wood bat**
 - c. If a player uses an illegal bat and gets a hit with such bat, then that player will be declared as being out and any runners will return to the base they were occupying at the time of the pitch.**
